Competency Board

The Home Office is introducing a new Interim (Fire Risk Assessor)
Competence Verification Board (ICVB) to work more closely with industry leaders to refine and finesse its delivery plan for implementation of Section 156(4) of the Building Safety Act and monitor progress.

The ICVB will be jointly chaired by Home Office and Fire Sector Federation and membership will include the FRA certification bodies and schemes, UKAS, NFCC and Developed Administrations.

The Industry Engagement group (IEG) will continue to provide a forum through which members of the wider fire and building safety sector can be kept up to date on developments and have an early opportunity to influence direction of travel. The next IEG meeting is on 15th April at 14:00 and anyone interested in attending should contact colin.coxton@homeoffice.gov.uk for an invitation.

DoT Battery Consultation

The Department of Transport has launched a consultation on proposals to double the wattage of e-bike



and e-cargo bike batteries.

Among the "potential disadvantages" identified in the proposals is "a risk of more severe battery fires from more powerful ecycles and this could be exacerbated by tampering."

NFCC Opinion Paper

The National Fire Chiefs Council has published an opinion paper outlining some of the key considerations for fire and rescue services when reviewing the design of high-rise residential buildings including:

Stairways are independent from each other and therefore a single fire cannot impact upon escape routes.

Safe egress is provided for all building users, including those who either would not be able to, or would find it difficult to descend stairs.

Suitable resilience and flexibility is provided for firefighting. This should include appropriate access and facilities, with sufficient resilience and redundancy in the design.

Social Housing Report

The Regulator of Social Housing (RSH) has published its latest fire safety remediation report for social housing in England covering buildings over 11 metres. The report summarises findings from the November RSH 2023 aggregate level survey and the progress made since its first survey.
